<p>\$150 billion</p> <p>Coronavirus Relief Fund</p>	State and local governments with populations over 500,000	The CARES Act requires that the payments from the Coronavirus Relief Fund only be used to cover expenses that — 1) are necessary expenditures incurred due to the public health emergency with respect to the Coronavirus Disease 2019 (COVID-19); 2) were not accounted for in the budget most recently approved as of March 27, 2020 (the date of enactment of the CARES Act) for the State or government; and 3) were incurred during the period that begins on March 1, 2020, and ends on Dec. 30, 2020.
<p>\$1.6 billion</p> <p>CDC Funding- Coronavirus Preparedness and Response Supplemental Appropriations Act and CARES ACT</p>	States and localities	Funds must be utilized to prevent, prepare for, and respond to the coronavirus.
<p>\$1.3 billion</p> <p>Funding for Health Centers – CARES Act</p>	Health centers	Expenses, including personnel costs, associated with prevention, preparedness, and response to COVID-19. <p>\$2 billion</p> <p>HUD’s Community Development Block Grant (CDBG) program funding for COVID-19</p>	State and local government	<ul style="list-style-type: none"> Construct medical facilities for testing and treatment. Acquire a motel or hotel building to expand capacity of hospitals to accommodate isolation of patients during recovery. Replace HVAC systems to temporarily transform commercial buildings or closed school buildings into clinics or treatment centers. Support businesses manufacturing medical supplies. Construct a group living facility to centralize patients undergoing treatment. Carry out job training of health care workers and technicians who are available to treat disease within a community.
<p>\$100 million</p> <p>Emergency Management Performance Grant (EMPG) = Supplemental</p>	Local and state government	<ol style="list-style-type: none"> <i>Planning</i>: Planning costs are allowed. <i>Organization</i>: Organization costs are allowed. <i>Equipment</i>: Equipment costs are allowed. <i>Training</i>: Training costs are allowed. <i>Exercises</i>: Exercise costs are not allowed under this program. <i>Consultants/Contractors</i>: Hiring of full-time or part-time contract planners or consultants to assist with planning and training activities is allowable under this program. Hiring public safety personnel fulfilling traditional public safety duties is not an allowable cost under this program. <i>Travel</i>: Domestic travel costs are allowed. International travel is not an allowable cost under this program unless approved in advance by DHS/FEMA. <i>Rental of Real Property</i>: Rental of real property space/locations is allowable under this program to support emergency management operations, including planning and training activities in a manner consistent with 2 C.F.R. § 200.432. Recipients are encouraged to use free public space/locations, whenever available, prior to the rental of space/locations. <i>Supplies</i>: Supply costs are allowed. <i>Construction and Renovation</i>: Construction and renovation costs are allowed. <i>Maintenance and Sustainment</i>: Maintenance and sustainment costs are allowed.
<p>\$13.2 billion</p> <p>Elementary and Secondary School Emergency Relief Fund</p>	State and local educational entities	Costs for state educational agencies for the purpose of providing local educational agencies, including charter schools, with emergency relief funding to address the impact that COVID-19 has had and continues to have on elementary and secondary schools.
<p>\$14.25 billion</p> <p>Higher Education Emergency Relief Fund</p>	Institutions of higher education	Costs for educational agencies for the purpose of providing higher educational agencies with emergency relief funding to address the impact that COVID-19 has had and continues to have on higher educational institutions.
